"When is the church building going to open?"

I have heard that question a lot over the last few weeks, and to be honest I have asked that question to myself a lot too. Like many of you, I am tired (and a little cranky) that we cannot meet in person and worship together. I miss game nights. I miss Sunday mornings. I even miss committee meetings! Overall, I miss people. And I know you do too.

Our Council has wrestled with many questions over the past few months. Many of those questions cannot be answered because we do not have the input we need to make an informed decision. So, we do our best to rely on the advise from the leadership of the Minnesota Conference, we discern the advise from health officials and we cautiously move forward with a plan to re-open the church building.

Below is a document the Union Church Council agreed upon in our last council meeting. We are in "step 2" right now, but understand there are people who may still feel more comfortable in step 1. That is okay. This plan has been designed so people can become involved again at their own pace.

No one knows when we make the transition to step 3, we do not have dates or times, but we will continue to remain aware of the health of our community and welcome the direction of those who are leading our conference.

Our community Wednesday meals are done until fall. They have been eagerly received and appreciated. We thank Sue Johnson and Mike Bohanon for all the hours they so willingly gave to prepare the food for this worthy project. They filled many tummies and made lots of people very happy. Thank you!!

Small groups may meet in the Friendship Hall. Attendance will be 10 or less people. Masks need to be worn, and participants need to sit at least 6 feet apart. Tables, chairs and anything that is used is wiped down with disinfectant.

Fellowship

We connect socially through phone calls, cards and outdoor visits with one another while practicing social distancing. Fellowship can also happen in the Friendship Hall with groups of 10 or less.

Committees

We meet and do business both in the Friendship Hall observing social distancing rules and virtually over Zoom.

Step 3 – Be Vigilant (Some Social Distancing Relaxed)

Council Minutes - June 18, 2020

Present: By social distancing at church: Pastor Torri, Linda Merritt, Jo Horak, Mike Bohanon, Joni Kumpula. By zoom: Caryl Allan, Karen Holle, Heidi and Don Hoppe, Ron Merritt

Joni called the meeting to order. Pastor Torri offered a convening prayer. The agenda was approved as written. The minutes were accepted as written. Heidi/Jo

Pastor's Monthly Report to Council: Coronavirus discussion: Pastor Torri began by sharing her report entitled "The Church Continues in spite of Covid-19. This report lists church accomplishments and goals of future work for the church. She then discussed the Union Church Covid-19 Plan for Reopening the Church Building which she had sent to all Council members. The group felt that we were currently at Step 2 of the plan which is:

Union Church Covid-19 Plan for Reopening the Church Building: Step 2: Be Cautious (Social Distancing is Observed)

Worship: Our worship services are streamed on the church's Facebook page, YouTube, and our website (www.unioncchackensack.com).

Education: Small groups will meet in the Friendship Hall. Attendance will be 10 or less people. Masks need to be worn and participants need to sit at least 6 feet apart. Tables, chairs, and anything else that is used is wiped down with disinfectant. A church member must be present in order for the group to meet.

Fellowship: We connect socially through phone calls, and cards and outdoor visits with one another while practicing social distancing. Fellowship can also happen in the Friendship Hall with groups of 10 or less. A church member must be present in order for the group to meet.

Committees: We meet to do business both in the Friendship Hall observing social distancing rules and virtually over Zoom.

Council agreed that there will be no private or personal use of the church at this time. (no rentals) Council also understands that many people may not want to attend meetings or worship at the church. They are encouraged to continue to connect via Facebook, YouTube or zoom.

This plan was approved by Council on 6/18/20. Don/Ron/passed.

<u>Sunday church service:</u> Pastor Torri feels that the current streaming of the Sunday services is going well. She would like for the Worship team to meet soon to work on a plan for in-person worship in the sanctuary.

<u>Woock-Ness Property:</u> Joni has been working with a team of people who are pursuing an environmental easement for the Woock-Ness property. This is to protect the land from development if the church folds. Joni will keep us informed as this process moves forward.

<u>Financial Stewardship Board:</u> Don indicated that our income for January – May of 2020 is significantly down from last year's income, but mentioned that our expenses are also down. The January – May income is \$64,996 and the expenses are \$57,789 for the same period which gives us a balance of \$7,288. We expect the PPP loan we filed for to help with expenses for the calendar year.

<u>Facilities:</u> Mike bought a new lawnmower which Johanna has been using and is happy with. Our two new furnaces are installed except for a little electrical work. Three trees that were hanging over the propane tank have been removed. Caryl volunteered her husband, Jim, to spray some poison ivy that is prolific near the church. Joni is working on getting rid of weeds that are growing by the church.

Ron is still working on the Solar Array Project with RREAL. Stan has upgraded the internet services in the sanctuary so that broadcast of church services can resume there.

<u>Personnel Board:</u> July semi-annual meeting: It is church custom to have a semi-annual meeting the fourth Sunday of July each year when we elect officers and ministry team members. This is also the time when the annual reports are prepared for each ministry team and board which are compiled for all to read. This year, due to the coronavirus, we will not have an inperson semi-annual meeting. Instead each team chair will prepare a report to be sent to Sabbastian by July 6. He will put the annual report together and will post it on our web-site. Anyone wishing a copy of the annual report can request one.

Officers and ministry team chairs agreed to continue their positions for another year, as we will not be able to have an

election to consider new officers. Motion to that effect: Don/Ron/passed.

Future leadership of the church: We discussed inviting several people to future Council meetings who are not currently involved in the leadership of the church. The invitation would be: "come and see what we do and see if you want to be part of this."

Ministry Teams: Congregational Life: Torri reported that there have been no meetings of the group, but people are being called and seem to be doing well.

<u>Worship:</u> Streaming of services is going well. Several new people are being trained to help Pastor Torri with the Sunday services. The Worship team will meet to discuss the topic of in-person worship.

<u>Women's Fellowship:</u> The group has not been meeting due to the coronavirus. Linda would like to have a small meeting in July for those that feel safe meeting in the friendship hall.

Men's Fellowship: Ron would like to get the men together on July 7 at 9:00 A.M. for coffee, donuts, and discussion for all who feel comfortable.

Christian Learning: The Bible Study group has been meeting (5-6 people) outdoors at individual's homes.

Community meal: The last Wednesday evening meal will be served June 25th. Eighty four people were served last week and \$257 was donated. The community meals will begin again in the fall. Jo Horak, Sue Johnson, Mike Bohannon, Don Hoppe, and Caryl Allan have made this program work.

Summer youth trip: Jo is hopeful that the youth can be involved this fall in another mission trip. The youth will have a table at the July and August flea markets to sell home-made crafts. Youth and their families will be involved in this fund raising.

Treasure Sale: Jo thinks that the sale will happen in August this year. She will prepare a plan whereby people visiting the sale or working at the sale can stay safe. This will be reviewed by Council at our July meeting. Jo will get the plan to Council members 3 days before the next meeting so we have plenty of time to review it.

Newsletter deadline: Tuesday June 23. After a closing prayer meeting was adjourned. Clerk: Karen Holle

Celebrating the Past - Myra Damm, historian

From 1907 when our church was formed Hackensack was growing, the church family was growing, but there was no building. On April 10, 1905 preliminary steps were taken toward a church organization. A paper to this effect was signed by fifteen persons, (I found another report that cited 21 persons) and in June of 1905 business meetings were held to elect officers to act until completion of church organization.

In September of 1907 the Good Will Gospel tent furnished by the Minnesota Congregational Missionary Society was pitched in Hackensack. Ten days of afternoon and evening meetings were held. Rev. Sheets was assisted by Rev. John E. Berry of Peoples Church of Brainerd and Rev. W. J. Conrad. At the close of the meetings it was decided to "perfect the church organization". On March 11th, a meeting to incorporate was held. Officers elected with specific terms were: James Curo: deacon for 1 year, A.H Fleisher: deacon for 2 years, and in June of 1908 "The Council Manual" was adopted as the church guide. In June of 1908 Rev. Sheets represented the church at a conference in Duluth and was instruction to make application for admission into the Congregational Conference.

Between 1904 and 1917, Church meetings were held at the Otterson Hotel, the old frame school house and members homes. In March of 1914 it was voted to accept Lot 9 in Block 3 in the village of Hackensack for the church building. On June 16, 1914 plans were finalized to build a church and in September of 1914 the committee hired Guy Beardsley to oversee the work. The foundation was finished in 1915, and on April 10, 1917, the building was started.

I have not found information as to the population of Hackensack in 1917, only the town was growing, the logging industry was thriving, and the railroad was the big means of transportation. More on the new church next time.

The Council has approved a plan for reopening which you can find elsewhere in this newsletter. I believe Union is now at Step 2 of that plan. Rest assured, however, that we will move forward slowly and carefully and take every precaution to protect our members and friends. Most importantly, please protect yourself. Should anyone propose moving to less stringent precautions and you do not feel comfortable with those changes (no matter how longed-for!), please do what is right for you to keep safe.

FINANCIAL STEWARDSHIP

We hope that this report finds you well and safe. Financially, Union Church is weathering the pandemic fairly well. Pledges and donations are coming in through mail and electronic funds transfers. Funds coming in last month were less than last year, but expenses were also down.

The Paycheck Protection Program (PPP) loan was approved and the eight week period finishes on July 2nd. Some or all of payroll expense and some of the utilities expenses may be forgiven by this program

BFS continues to be concerned about donations by not having in-church worship. Many friends and members and visitors do not pledge, but donate at worship services. We broadcast our worship services on Facebook Live, YouTube, and on the Union Church website. We also have a Donate or Give button on our website, but we are not seeing the amount of giving for our on-line worship services that we hoped for. The Church Council and the Worship Ministry Team will decide when and how in-church worship resumes.

The Community Meal program finished the last Wednesday of June. It was a real success, a great program and ministry. Meals were prepared for about 80 persons a week, and the program was extended for about 6 weeks this year. Meals were picked up curbside or in some cases delivered by volunteers. The many donations and generous gifts supported this ministry.

How can you donate to Union Church, without being physically at Union Church? There are numerous of ways to do this.

- 5. Think about establishing a legacy gift to Union Church.

We hope that you stay healthy and safe and look forward to the time when we can return to being closer together. But we also know that this pandemic will have a continuing effect and ramifications on how we will be the church in the future. Let us be open to and embrace these changes.

Summer is here! Many things have changed since last Summer. Union Church had just finished a very successful Treasure Sale and was preparing for a wonderful three day VBS Program. Delightful!

This year we decided to move our Space Explorers VBS Program to next Summer. The extra time will enable us to build a bigger, better program. Special thanks are due to all those who agreed to set-up classrooms, teach Bible lessons, lead activities like music, art, outdoor explorations, swimming, kayaks, canoes, and the Deep Portage Day Program. People working at the Fishing Pier supported kids in a (for some) new experience with wit and wisdom. Remember that many of the disciples of Jesus were fishermen!

Finally, extra-special thanks go to the Meal Team who furnished Lunch for kids and adults with delicious meals, healthy snacks, and lots of creative options while doing it. Lots of fun too!

Last year the Snack Crew blended both kids and adults to make good snacks happen. Just writing about it makes me smile (and a little hungry too)! Can't wait for VBS 2021!

Meanwhile, the Community Meal Program has ended for the Summer. Wednesday, June 24th. As of this writing final numbers are not in but we estimate serving almost 800 meals.

This Mission Project was begun as a extension of our Indoor Community Meal Nights. We use our Upper Level Commercial Kitchen, practice safe kitchen practices, and provide healthy meals for pick-up or delivery to all who wish to receive them. Due to creative menu planning/purchasing by Sue and Mike, prep/pick-up by Jo, prep/delivery Caryl, and delivery by Don it worked. Substitute drivers are Gardener Mary and Wendy. Thanks to all of you who supported this program for SIX EXTRA WEEKS with prayers, donations, and help as needed. We are very grateful for involvement of Pastor Torri and our Union Church Council in making this Christian Learning Project able to fill a need in our community. We served 60-80 weekly. All participants really made a difference in many lives. We will resume in early Fall. Thanks be to God!

Looking ahead, we hope to have two small fund raisers for more Youth and Families programming later this Fall. The Sacred Heart Church plans to hold two Flea Markets this Summer - Wednesday, July 8th and Wednesday August 12th. Families will have a donated table at both markets and offer Made In MN items to fund our October Mission Trip. All safety/health precautions will be observed.

Treasure Sale Status: Possible. At the June Council Meeting it was determined that if Christian Learning could provide a plan three days in advance of Council Meeting for a review and it was approved we would hold a sale in connection with Sacred Heart August Market. Treasure Sale would require modifications for our guests like Costco, Menards, and other stores/events. Numbers inside at one time may be restricted, masks required, and more. Final details are being discussed. This event funds several salaries/activities connected to our Youth and Families Program so prayers are asked for success of this sale. Monday Morning Bible Study has been gathering outdoors at different homes during Spring/Summer with great success. We use the Upper Room materials and other Bible resources. WE HAVE ACCOMPLISHED:

We have developed online services that stream live to our Facebook page, YouTube and website.


